



Volunteer Waiver

I, _____, on behalf of myself, my personal representatives, assigns, heirs, and next of kin, do hereby agree to indemnify and hold harmless the Greater Baton Rouge Food Bank, its employees, volunteers or agents (the "Released Parties") from any and all claims or causes of action that may arise out of the performance of my assigned duties as a volunteer. I waive any right of action I have against the Released Parties in consideration of my participation as a volunteer for the Greater Baton Rouge Food Bank.

I attest that I am not experiencing any symptoms of illness such as a fever, cough, or shortness of breath. If I develop these symptoms, I agree that I will cancel my shift before arriving at the Food Bank, as far in advance as possible.

I will adhere to 6-foot distancing procedures, wear a mask at all times, and use gloves while working with food.

I attest that:

- I have not traveled internationally in the past 14 days
- I have not traveled to an area within the United States in the past 14 days that is highly impacted by an illness considered a public health emergency, such as COVID-19
- I do not believe that I have been exposed to a person with a confirmed or suspected illness designated a public health emergency, such as COVID-19
- I have not been diagnosed with an illness considered a public health emergency, such as COVID-19
- If I have contracted or been exposed to an illness considered a public health emergency, such as COVID-19, I have been cleared as non-contagious by state or local public health authorities
- I am following recommended guidelines as much as possible-practicing social distancing trying to maintain separation of six feet from others, and otherwise limiting my exposure to an illness considered a public health emergency

I agree to abide by the Greater Baton Rouge Food Bank's safety and sanitation standards. To the greatest extent permitted by applicable law, the Greater Baton Rouge Food Bank shall not be held liable if I contract any illness considered a public health emergency, such as COVID-19, from volunteering at the Food Bank or participating at one of its sites.

I understand that volunteering at the Greater Baton Rouge Food Bank may involve working in warehouse conditions including but not limited to: lifting, working around heavy moving equipment, and handling food products including products containing potential allergens. I am expected to follow safety rules and all other rules related to the warehouse. I hereby accept and assume full responsibility for any injury I might suffer while volunteering at the Greater Baton Rouge Food Bank.

If I am a parent or guardian of a minor who volunteers for the Greater Baton Rouge Food Bank, I release and forever discharge any and all rights, claims, and causes of action that I may have against the Greater Baton Rouge Food Bank Responsible Parties for any injury, loss or damage in any manner to the minor child, whether caused or contributed to, in whole or in part, by any act, omission, conduct or negligence of the Greater Baton Rouge Food Bank Responsible Parties. The Greater Baton Rouge Food Bank also has permission to use my voice, name, likeness, photograph, or videotaped image in publicity about the Greater Baton Rouge Food Bank and its activities. If I am a parent or guardian of a minor who volunteers for the Greater Baton Rouge Food Bank, the Greater Baton Rouge Food Bank, also has permission to use the minor's voice, name, likeness, photograph, or videotaped image in publicity about the Greater Baton Rouge Food Bank and its activities.
